- 2. Students of Classes from Nursery to 1st Standard shall be located at ground floor only and the Class 2 students shall be located not above first floor.
- 3. Building stability and satisfactory electrical installation to be ascertained from concerned agency.
- 4. FCC shall stand null and void if there is any violation in existing firefighting arrangements.

operate all fire safety equipments.

- 7. Any loss of life or property due to non-functional fire safety measures shall be at the responsibility of the management.
- 8. All staff should be trained in firefighting. Trained firefighting staff should be available during school hours.
- 9. Any deviation with regard to construction etc. shall be verified by the concerned building sanctioning authority.
- 10. Occupant load in class room should be calculated at not less than 4 m2 per students.
- 11. No combustible material should be used for construction of school building.
- 12. No cooking should be done within the school building.
- 13. The firefighting equipment register, mock drill register and staff training register should be updated regularly.
